7. The bids will be opened in the presence of Bidders' representatives who choose to attend **at 14:00 hours on 2078-08-10** at the **Jayaprithvi Municipality, Chainpur, Bajhang**. Bids must be valid for a period of **45 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of as stated in above table, which shall be valid for 30 days beyond the validity period of the bid.
