- 4. Pre-bid meeting shall be held at Jayaprithvi Municipality at *12.00 on 2077.07.06*.
- 5. Bidder shall have the option of submitting their bid electronically only. Submission of Hard copy bids shall not be entertained.
- 6. electronic bids must be submitted to the office or through PPMO website <u>www.bolpatra.gov.np/egp</u> on or before *12:00* on *2077.07.18*. Bids received after this deadline will be rejected.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend *at 14:00 hours* on 2077/07/18 at the Jayaprithvi

Municipality, Chainpur, Bajhang. Bids must be valid for a period of *90 days* after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of as stated in above table, which shall be valid for 30 days beyond the validity period of the bid.

- 8. If Bidder wish to Submit the bid security in the form of cash bidder has to deposit cash in Dharauti Account no 4110100303000004 of Jayaprithvi Municipality, Chainpur, Bajhang at Rastriya Banijya Bank Bajhang Branch, Bajhang and Submit Bank Deposit Voucher along with a Bid.
- 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 10. Any Condition so far not stated in this Notice will be As per PPA 2063 and PPR 2064 and its Amendments.
- 11. Any Amendments in This tender Notice will be posted in the notice board of Jayaprithvi Municipality, Bajhang or may visit PPMO e-GP system www.bolpatra.gov.np.
